Historical note: This record group contains records relating to the many functions the Town Clerk has carried out since Amherst's establishment. In addition to the Town Record Books (RG 1) and Clerk's copy of the Invoices and Taxes (RG 6), the Clerk has recorded vital statistics, better known as births, marriages, and deaths or BMDs, first in early Town record books and later as a function required by State statutes and regulations. Election records, many types of licenses, writs, lists of selected jurors, oaths of office, appointments, and town ordinances have all been maintained by the Town Clerk. The Clerk's Office also kept track of its own financial transactions as reported to the Treasurer. A list of Town Clerks can be found in the two histories of Amherst.

A brief overview of the records follows.

Vital Records. Vital records/statistics are births, marriages, and deaths registered with the Town Clerk. The earliest ones were recorded in the Town Records Books. A 1791 state statute required ministers and justices of peace officiating at a marriage to keep a record and submit the certificate to the Town Clerk by March of each year. Certificates of births and burials were also to be given to the Clerk within a month of the event. The Clerk was to record all these events in the Town Record Book. This process continued in Amherst until 1842 when the Clerk began separate books to record the information. Then in 1866 the information was also to be provided by the Clerk to the State (Secretary of State.) In 1905 the Bureau of Vital Records was established and filing become more standardized. Cemetery Records. While most cemetery records are maintained by the Department of Public Works, some older records remain in the vault. The elected Cemetery Trustees work in conjunction with the Sexton on the management of the Town's four cemeteries.

Naturalization Records. From the time the first naturalization act was passed in 1790 until 1906, there were no uniform standards in the United States. As a consequence, various courts generated a wide variety of citizenship records. After 1906 the vast majority of naturalizations took place in federal courts. Source: Ancestry.com

In NH an 1855 act "Regulating Naturalization and the Suffrage of Naturalized Citizens" required such a citizen who wished to vote to produce for selectmen his naturalization papers at least three months in advance of the election. If the papers were in order, his name was added to the voter check list and would remain as long as a resident. That section of the legislation was repealed in 1862. The single volume in Amherst is for a longer interval of time and its underlying purpose is not clear.

Dog Licenses. In 1891 "An act to prevent the destruction of sheep and other damages by dogs" (chapter 60) stated in Section 1: "Every owner or keeper of a dog three months old or over <u>shall</u> annually, on or before 30th day of April, <u>shall</u> cause it to be registered, numbered, described, and licensed for one year from the first day of ... May, in the office of the clerk of the city or town ..." Section 3 stipulated that the fee would be \$2 for a male dog and \$5 for a female dog, and such proportionate sum for licenses for dogs becoming three months old after the first day of May. Per Section 6, town clerks were required to keep an accurate and separate account of all moneys received [for dog licenses]. The annual licensing of dogs remains one of the Clerk's functions.

Dogs appear in other municipal records. A state law in 1863 required the selectmen to include dogs in their assessment and collection duties. Taxation of dogs began as a war revenue measure in 1862 that did not end until 1893.

Chattel Mortgages. Chattel (personal property) mortgages were the nineteenth and early twentieth century equivalent of today's installment purchases where the seller retains interest until the loan with interest is fully paid.

Writs of Attachment. A writ of attachment is a court order to "attach" or seize an asset to satisfy a judgment issued by the court. The Town Clerk of Amherst began recording an index of such writs against residents of Amherst, pursuant to a new N.H. law of Dec. 1848. There is no indication of the nature of the suits, amount of the judgments, or how resolved.

Juror Selection; Municipal Court. The Clerk was responsible for maintaining lists of individuals chosen for jury duty. There are two volumes. One entitled Records of Jurors Selected, 1929-1970 contains partially printed forms indicating the Clerk had selected day, time and place of drawing of jurors, Clerk's certification, and names of those selected.

Also included in this series but <u>not</u> related to the Clerk's responsibilities are two Law Notes notebooks left by the last Municipal Court Judge Charles Lincoln. The Town Hall originally housed the county court until 1879. Later, between 1951 and 1964, it was the location of the Municipal Court These notebook evidently were left in the vault.

Appointments. The Clerk maintained a record of appointed and elected town officials including their signed oaths of office. Other sources of such information are the two

Amherst histories and annual town reports.

The volumes in this series contain partially printed forms; each record includes name & position, duration, names of selectmen who made the appointment, date on which oath of office was made, signature of Justice of Peace before whom oath was sworn, and signature of Town Clerk attesting to accuracy. (JP and Town Clerk were often the same person.) Appointed positions include the tax collector, fire wards, town treasurer, and election inspector.

Regulations, Ordinances & Other communications. 1959-2011. The Clerk is the recipient of filings from other municipal entities and communications from state or county authorities. Two document boxes contain those that were found in the vault. They are arranged in chronological order.

Financial. **1955-1982.** The Clerk maintained her/his own ledgers showing daily transactions. They include receipts, notably motor vehicle registrations and dog licenses, and the payment to the Town Treasurer.

Conditions governing access: Access to vital statistics is governed by the State of New Hampshire through legislation and regulations.

New Hampshire vital records are considered to be private and access to them is restricted by statute to those individuals who have a "direct and tangible interest" in the record. To view all of the disclosure limitations, click on this link to NH statute: <u>RSA 5-C:9</u>. Certain older records are exempted from these access restrictions: "Birth records more than 100 years old and death, marriage, and divorce records more than 50 years old shall be considered part of the public domain." (<u>RSA 5-C:105</u>)

Alternatively, upon receipt of a completed application, positive identification and the required fee, Vital Records staff will research records.

Vital records were/are included in annual town reports of Amherst starting with calendar year 1884 (in 1884/5 report); in the late 20th century, parents were given the choice of confidentiality so not all births are published.

Cemetery Records.

The Director of Public Works, as Sexton, maintains cemetery records in the Public Works Department Office at 22 Dodge Road, Amherst. They are limited to those that will enable the town to locate by name and date, every interment or removal and the exact location within each lot.
